The Australian and Victorian Governments are undertaking a Major Event Review (MER) into the impacts of the 2019-20 bushfires on the five long-term forest management agreements between the Australian and Victorian Governments, known as Regional Forest Agreements (RFA).

The MER is being conducted by an independent Panel comprised of:

- Dr Gillian Sparkes, the Victorian Commissioner for Environmental Sustainability;
- Ms Katherine Mullett, a proud Gurnaikurnai, Ngarigo Monero woman with a strong background in Culture Heritage Management and Land Management; and

Dr Tony Bartlett, who has experience working in Australian and international forestry.

As part of the MER, the Panel would like to hear directly from communities on the impacts of the 2019-20 bushfires. This may include views on the impacts of the bushfires on forest management, environment and heritage including cultural heritage, economic and social values of forests, stability of forest industries and impacts on forest species and communities and any remedial actions you think could be taken.

DELWP – Private Overhead Electric Line (POLE) Scheme

Victorian Government, Department of Environment, Land, Water and Planning (DELWP) has allocated \$5 million to replace bare-wire private overhead powerlines in Victoria's highest risk bushfire areas. Interested applicants who wish to apply for the POEL Scheme must meet the following requirements: The POEL must be bare wire, the type of conductor which presents the highest risk (not insulated more than 50 per cent).

Lucas Mill Project to mill logs felled as a result of last years fires

A partnership project between Rotary and Lions (supported by DELWP; Dwyers; Riviera Trailers; Bendigo Bank and BJ Crane).

The project is to mill into useable timber (fence posts; stockyard fencing and shed timber etc) logs from trees that have been felled or fallen as a result of the 2019 / 2020 fires – using a Lucas Mill (portable sawmill). Logs need to be at least approx. 450mm in diameter and can be up to 6m length.

The logs will be milled at no cost to the landholder. The team operating the mill are currently being professionally trained and the project will observe all OH&S issues as well as having comprehensive public liability insurance. Those registering will be placed on a waiting list.
